The following information applies to the period of Jan. 22-28:

Lane closures or restrictions are expected at the following locations due to road/utility work:

- Fairview Drive will be reduced to one lane in both directions between Saliman Road and Roop Street from 7 a.m. to 5:30 p.m. Tuesday-Thursday.
