With Governor Sisolak's most recent press release, as of May 1, 2021, State Emergency Directives will no longer include social distancing requirements and returns the decision-making authority back to local school districts. In addition, this new guidance provides the District the opportunity to bring all Pre-K through 12th grade students back on campus for inperson instruction, five days a week, Monday – Friday, starting May 3, 2021.
