



- 1. Adoption of the agenda, as submitted **for possible action (public comment will be taken prior to any action).** Mr. Thornton motioned to approve the agenda. Mrs. Lawlor seconded. The motion passed unanimously.
- 2. Approval of the FLAC minutes from February 7, 2022 **for possible action.** It was noted that under item number 1, *minutes* should be changed to *agenda*. Mrs. Lawlor motioned to approve the minutes with the indicated correction. Ms. Lewis seconded. The motion passed unanimously.

- Review of the suggested changes for the Family Life Advisory Rules and Procedures for possible adoption. – for possible action. The committee reviewed the changes. No public comment was submitted. Mrs. Lawlor motioned to approve the draft changes to the FLAC Rules of Procedures to be sent to the school board for approval. Mrs. White seconded. The motion passed unanimously.
- 4. Discussion on the process for sharing committee reviewed materials with the CCSD Board of Trustees for approval. for discussion only. The committee discussed Mr. Stokes's suggestion to submit the items to the school board twice a year under the consent agenda and that the school board can move the item to a regular agenda item if needed. The committee added this verbiage to the Family Life Advisory Rules of Procedure. Mrs. Lawlor motioned to approve the draft of the Rules and Procedure with the revised changes under section 1.2 Curriculum Materials. Mr. Thornton seconded. The motioned passed unanimously.
- Review of materials submitted by Ms. Jones as possible non-family life material to make available to teachers on the topic of RAIN, a social-emotional self-regulating strategy. – for discussion only. Ms. Lewis suggested Mrs. Jones offer the content to the Mrs. Cleveland, who is coordinating the district's SEL curriculum development. Mrs. Story will connect Mrs. Jones with Mrs. Cleveland.
- 2. Public Comment: No public comment was offered.
- 3. Discussion item: Mrs. Jones asked if we can share resources with other counties. The group agreed we can. This brought up a discussion around an increase in juvenile sexual offenses and the need for instruction on boundaries. Mrs. Lawlor, Mrs. Jones, and Ms. Lewis have resources on this topic. This will be addressed at our May meeting.
- 4. Mr. Thornton motioned to adjourned. Ms. Lewis seconded. The motion passed unanimously. Meeting adjourned at 8:16 p.m.
