## MINUTES

Introduction of Committee Members

Sheila Story (chair), Ananda Campbell (teacher), Stephanie Cook (parent), Kyndra Jones (parent), Amanda Beer (counselor), Dan Thornton (parent), Linda Lawlor (parent), Betsy Campbell (student), Sawyer Macy (student), and Cheryl Macy (district).

- 1. Adoption of the agenda, as submitted for possible action (public comment will be taken prior to any action). Cook, Thornton passed unanimously
- 2. Approval of the FLAC minutes from October 30, 2023 for possible action.
  - Title of document changed from AGENDA to MINUTES.
  - Ms. Beer's name was corrected on item number 2.
  - Mr. Thornton made a motion to approve the minutes from October 30, 2023 with the noted changes. Ms. Ananda Campbell seconded. Motion passed unanimously.
- 3. Review of the following videos by: Human Relations Media for possible action (public comment will to taken prior to any action)
  - You, Your Body and Puberty

      - Ms. Cook thought the video explained things well. Ms. Jones explained that she liked the information covered real life changes, such as a body odor changes. Ms. Lawlor liked that the adult the children talked to represented different relationships. Ms. Ananda Campbell noted that the lack of seatbelts was concerning and that the video is old, but that the information was good. She also liked that there were a number of comments about thinking about the kind of adult you want to be and that differences are normalized. Ms. Betsy Campbell thought the style was old, but that the content was good. Mr. Macy thought the straight-forward the content was solid and absent of silly jokes. Ms. Betsy Campbell and Mr. Macy stated that they were both engaged, but they would prefer a newer video. Ms. Ananda Campbell suggested that we make sure we don't already have it in the district. Ms. Ananda



Campbell noted that approving it for 5<sup>th</sup> grade would mean the video might be shown in 5<sup>th</sup> grade, making it difficult to teach in 7<sup>th</sup> grade.

• Ms. Lawlor made a motion to approve the resource for 6<sup>th</sup> and 7<sup>th</sup> grade with the recommendation that the teacher seek out more up-to-date products. Mr. Thornton seconded. No public comment. No further discussion. The motion passed unanimously.

- o Mommy, Daddy, Wait for Me: Struggles of Teen Parents

  - Mr. Macy noted that this video relies on fear tactics. Ms. Lawlor noted that while fear is the focus, much of the content is accurate. Ms. Cook explained that the content is not necessarily universal. Ms. Lawlor explained that the financial issues noted in the video are true for a couple she knows who are currently going through a similar situation. Ms. Beer expressed concern that the video offers no hope, and Mr. Macy noted that the video discourages ever having children. Ms. Beer noted that the video states that condoms cost \$3, but they currently cost \$9, but she liked that the video talks about means of getting birth control. Ms. Story explained that Carson City Health and Human Services offer free condoms. Ms. Ananda Campbell did not like the language regarding a "normal" birth in reference to a vaginal birth and language regarding one father having to "man up." Ms. Story noted that the statistics are likely outdated, such as the percentage of teen mothers having to have a C-Section. Ms. Ananda Campbell noted that the 7<sup>th</sup> grade curriculum should include information about what it means to have a child regardless of age, not just as a teenager. Ms. Cook explained that fear tactics are proven to not be effective with teenagers. Ms. Ananda Campbell motioned to reject Mommy, Daddy, Wait for Me due to outdated information, fear tactics, and negative portrayal. Ms. Cook seconded. Ms. Beer noted this video would make her feel bad if she were a teen mother, and Ms. Cook noted that there are young women who are victims of rape. No public comment. Motion passed unanimously.

  - Ms. Jones noted that the video was outdated in terms of HIV treatment. Mr. Thornton noted that the entire second half of the video was an anti-AIDS advertisement and is not appropriate for the topic. Ms. Story noted that the statistics are outdated due to the video being about twenty years old. Ms. Ananda Campbell explained that during an era when we were trying to change understanding of AIDS by explaining that it's not just a gay man's disease, the video was appropriate, but for today's understanding, this video is not appropriate. Ms. Ananda Campbell made a motion to reject the video based on outdated scientific information. Ms. Cook seconded. No public comment. No further discussion. Motion passed unanimously.
