Mission Statement

In partnership with families and the community, we will make the most of every day for every student by empowering them with the skills, knowledge, values and opportunities to thrive.

Superintendent's Highlights

While no single report can tell the complete story of our education accomplishments, the following highlights occurred during the 2019-2020 school year.

- For the fourth year in a row, Carson City School District's high school students graduated at the highest rate ever at 86.79 percent for the Class of 2019.
- Nicolas Jacques, band teacher at Carson Middle School, was recognized as a 2019-2020 recipient of the Milken Educator Award, which also earned him an unrestricted \$25,000 cash prize.
- The NJROTC program at Carson High School earned a Distinguished Unit award with Academic Honors for the second year in a row. The program was also recognized as the No.1 unit out of 47 units within the region, ranking them in the top 11 programs in the nation.
- The Carson High School Girls Cross Country Team was honored as the 2019 NIAA Academic State Champions, averaging the best GPA of all 4A schools in the state at a 3.96.
- The Carson City School District and School Board of Trustees hauled in nearly a quarter of all the Nevada Association of School Boards (NASB) awards (4 out of 19) among the 17 districts statewide.
- Carson City School District embraces the use of technology and provides a 1-1 device (Chromebook computers) for students in grades 3-12, which assisted greatly when forced to execute remote learning plans during the last quarter of school when closures took effect due to COVID-19.
- Carson City School District's communication department distributes quarterly newsletters to nearly 22,000 individuals throughout Carson City. Recipients include students, parents, guardians, teachers, staff, community partners and more.

Goals and Objectives

Recruit, provide professional growth opportunities, and retain exceptional personnel for all positions within the school district.

District Communication Efforts

The Carson City School District televises the Board of Trustees through access television twice each month. Each school distributes a monthly newsletter to parents and community members as a means of keeping the public informed about school activities, programs, and events. Elementary schools hosted Parent/Teacher conferences at the end of the first quarter, and then again at the end of the third quarter. Test results and interpretation guides are sent home at the completion of each standardized test cycle. Each school maintains a website providing school-wide information. The district provides a website (www.carsoncityschools.com) where parents and community members can obtain information regarding policies, procedures, curriculum and assessment results. Elementary schools utilize PeeChee folders to communicate with parents on a weekly basis. Each school hosts school-wide activities to encourage parent participation, i.e science fairs, family reading nights, math nights and a variety of other social events. The high schools and middle schools utilize Infinite Campus so parents have access to grades, attendance and announcements 24 hours a day via the computer.

Discipline

It is the policy of the Carson City School District to provide regular in-service education and training about harassment, sexual

harassment, intimidation, and bullying for employees and students. Such in-service training shall include:

- Methods to improve the school environment that will facilitate positive human relations among students;
- Methods to facilitate positive human relations among students without the use of bullying and/or cyber-bullying;
- Methods to teach students positive behavioral replacement strategies;
- Requirements and methods for addressing the needs and rights of students with diverse gender identities or expressions;
- Training regarding the methods, procedures and practice for recognizing bullying and/or cyber-bullying;
- Training regarding effective interventions and remediation strategies for bullying and/or cyber-bullying; and
- Training regarding methods for reporting violations of NRS 288.135.

Curriculum Details

The Carson City School District provides a comprehensive Nevada State Standards based Pre-K-12 curriculum that involves core subject areas, arts, humanities, physical and career technical educational opportunities to meet the diverse needs of our student population. The District's Learner Centered Model emphasizes a personal learning environment for academic to promote college and career readiness for all students.
