## State's hospitality jobs drive increased employment in June

In a strong sign for the Las Vegas area, job growth



in leisure and hospitality doubled in June compared to the previous month.

Dave Schmidt, chief economist for the Department of Employment, Training and Rehabilitation, said the food service sector is now nearly fully recovered to pre-pandemic levels with more than 131,000 workers. Food service and drinking placprimarily seasonal reductions in education over the summer.

Altogether, the state added 15,400 jobs in June for a total employment of 1.336 million. That leaves 58,900 people still looking for work.

51, pleaded not guilty to
four charges in 2019 to
the murder of Charles

stand trial. Psychologists Amy Patterson and Debbie Fletcher also reached the conclusion O'Connor wouldn't be able to assist his counsel.

Maddox then vacated the trial for O'Connor, which was expected to begin in March.
